



YOUTH MOBILITY SCHEME

The goal of this reciprocal cultural exchange program is to give young people from participating nations, between the ages of 18 and 30 (or 18 to 35 for certain nationalities), the chance to live in the UK for up to two years (or three years for nationals of New Zealand). During this period, the visa holders may live, study, work in most occupations, or run their own business in the UK.



GLOBAL TALENT ROUTE

Internationally renowned experts in science, humanities, engineering, arts, and digital technology are encouraged to use this route to seek employment in the UK. The top highly skilled foreign talent may enter the UK without a job offer; however, they will first need to obtain endorsement from an approved and recognised UK body.

INNOVATOR FOUNDER PROGRAMME

This route is intended to draw entrepreneurial talent from overseas, focussing on forward thinkers who want to launch a cutting-edge business in the UK. The UK welcomes business-minded innovators who are prepared to scale up and expand their businesses by bringing innovation to the UK market and beyond.



SCALE-UP ROUTE

The Scale-up visa route is open to individuals who receive a job offer from a qualifying fast-growing UK company (a 'scale-up business'). The offered role must require a sufficiently high level of skills from the candidate and meet the specified salary threshold. This programme aims to facilitate access to foreign talent for the UK's fastest-growing companies.



GRADUATE ROUTE

This is a post-study immigration route for foreign students who have graduated from a qualifying course at a UK university. After completing their education, holders of Graduate visas are permitted to stay in the UK for up to three years and pursue employment at any skill level.

HIGH POTENTIAL INDIVIDUAL ROUTE

Recent graduates of prestigious international universities may take this unsponsored route. A High Potential Individual visa allows the holder to remain in the UK for up to three years while working or looking for work at any skill level.


